It is important to grasp the concept of the gift economy because most people are unaware of alternatives to the central banking fiat currency economy, other than a gold-based economy. However, a serious problem of a gold-based economy is that some one or some group would eventually hoard all or most of the world's gold supply, and thus have unbridled socio-economic power. Because of the degree to which the concept of money is ingrained in the human psyche, it may take several generations for a gift economy to be fully embraced. Nevertheless, being aware of the concept of a gift economy provides a stimulus for people to think and socially *evolve to the high state of consciousness required by a gift economy.*

Bankers' Secret of Creating Fake Loans

It is appalling how the central banks of First World countries create artificial debt, and through that false debt, or illusion of debt, enslave the human race. Why are bank debts, on any scale from petty credit card debt to third world debt, artificial, false or illusory, that is, not true loans? Well, banks generally do not lend pre-existing money of their own or money they hold for depositors or investors. The money loaned by banks, if it can even correctly be called that, essentially consists of ledger entries. . . Banks simply press a few keyboard keys and the money is there, created by fiat. This creates two types of people in the world: Those who create money out of nothing, and those who must work for it. Hence, bankers have an unconscionable advantage over everyone else. Please understand that when I say "bankers" I am not talking about the bank tellers and loan officers at your local banks. I am referring to the super wealthy Illuminati bankers that have been herding humanity into servitude through fake debt.

Tom Schauf, a Certified Public Accountant (CPA) court expert witness and author of a couple of revealing (and suppressed) books titled *America's Hope to Cancel Bank Loans Without Going to Court* and *The American Voters Vs. The Banking System: The Technical Guide to America's Hope*, Volume 2, explains fake

bank-created debt or the “bankers' trick” something like this:

Let us say John Public signs a promissory note (a promise to pay, an IOU) in the amount of \$20,000 for a loan. The bank takes John Public's promissory note. Then the bank deposits the value of the promissory note in its favor (by means of pressing a few keyboard keys), withdraws the money, then returns it to John Public, and claims that it is the bank's loan to John Public. The bank stands to lose nothing if John Public does not pay the false loan. The bank never loaned any of its own money. It never put any of its money at risk or that of depositors or investors. The fake loan is just the bank giving the value of the promissory note created by John Public back to John Public. That is the maneuver or trick banks use to “lend” without lending any of their money. That is standard banking practice. It is akin to some one stealing your car, then coming back and requiring you to pay for it if you want a car like the one you had, except it is done in a concealed unrevealed way. There is no full disclosure. Note that in credit card Terms and Conditions, there is plenty of talk about how you must pay them, at what interest rate, what the penalty late fees are, and often litigation threats about what they will do if you do not pay. There is never explicit mention that they lend their money or money held in trust. You can test this yourself by asking them directly:

Dear [Bank of your choice]:

Regarding the debt you claim against me, did you lend me your money existing prior to making me the loan you claim?

This is a question banks will avoid answering. They will simply not answer, give you a tangential rhetorical response that does not answer the question, or threaten that you better pay or else.

The discovery of how modern banking operates is so shocking that it becomes a major wake-up point for many people regarding how humanity is enslaved through deception. As in the popular movie *The Matrix*, people can take the blue pill and continue as if nothing is happening or they can take the red pill and gradually see the panorama of the astute secret control of the Illuminati or similar groups. But dear reader, do not believe me, look up this information yourself. Do some Googling on the web. In any case, it is time for a public discussion about the banking issue: Let everyone know, think, and decide about the kind of world we want to live in. There are alternatives that I believe can create a world much like

Heaven on Earth for everyone! However, we will create a better world only if we become more aware and strive for true spiritual awakening.

The IRS: Sister of the Federal Reserve

Around the same time that the current central bank in the USA was legislated into existence under questionable circumstances, equally conniving was the creation of the Internal Revenue Service, which many view as the collection strong arm of the privately owned Federal Reserve System or central bank in the USA. Again, awareness of the basis of the IRS is another wake-up point for many people. In fact, most people who become knowledgeable regarding the hidden operations of the Illuminati first begin educating themselves when they are harassed by the IRS, which operates on fear, deception, guilt, and ignorance, and have no place in a world based on Love, Light, and Freedom.

According to Bill Benson and Red Beckman, authors of the two-volume work *The Law That Never Was*, the Sixteenth Amendment to the Constitution for the United States of America, which created the IRS, was never truly ratified. Also, certain court cases have ruled that the Sixteenth Amendment “does not extend the power of taxation to new or excepted subjects...” (Peck v. Lowe, 247 US 165). The Sixteenth Amendment was a sneaky underhanded attempt by the Illuminati to further their agenda. But to some extent they succeeded through obfuscation and have managed to deceive millions of Americans for generations into paying taxes never intended by the Constitution or the Founding Fathers of the USA.

Yet looking beyond the invalidity of the Sixteenth Amendment, people need to ask how they became taxpayers? This question is seldom asked. And even more seldom answered: Unbelievable as it sounds, in reality there is no specific law that requires anyone to become a taxpayer (The Constitution does not allow it.). The Internal Revenue Code (Title 26 United States Code), which consists of thousands of pages of minutia and cross-references, is written more to deceive and confuse than to layout a clear outline of law. What kind of mentality would write such a mishmash of confusion? One thing that is obvious is that the IR Code and the IRS only directs itself to taxpayers. It applies only to taxpayers. If an individual is a non-

taxpayer, which is different from a tax protester, the IRS has no business addressing that individual. The IRS only deals with taxpayers. If there is no law that requires one to be a taxpayer then how do people become taxpayers? I believe it is because, not knowing any better, they are led to believe that they must be taxpayers because they assume it is the law, and they have no choice. People become taxpayers and abused by the IRS because they act like taxpayers. Shame on so-called tax professionals such as most accountants and tax attorneys that do not inform their clients about this. . . but then if they did, there might be a conflict of interest.

In the world of Light and Love that the spiritual awakening of humanity will bring, the ways of the IRS will not be acceptable. I think undoubtedly the days of the IRS are numbered. Yet before abusive taxation is put behind us, the Illuminati may attempt to expand taxation enforcement on a world scale through the United Nations or some other world governing organization. I pray that people be awake, well rooted in spirit, and not allow it. The Illuminati are not misguided because they are wealthy. Wealth is not in itself evil. The Illuminati are undesirable because they are acting to exploit humanity for their self-serving interests, although they carry out their schemes under the guise of benefiting and protecting the public.

Positive ETs

In our universe of polarity there are also extraterrestrials of the positive kind from higher dimensional worlds who are with us and among us. Some of them are marginally known, such as Sananda, Ashtar, Monka, Kuthumi, St. Germain, and others entirely unknown. The following is a message from Monka that appears in *UFOs— Keys to Earth's Destiny* by Winfield Brownell:

“We have many many ships that are going through your atmosphere at all times; and now and then, here and there, we are helping more people to experience sightings of the ships, and some are being taken for trips. There is more of this type of activity, but it is just incidental. We are looking forward to the time when we can *land* in great numbers. We cannot land as long as too many Earth beings have *fear*. The condition of your feeling world is our test to tell whether or not we should bring in the ships in large numbers and land, before the serious cataclysmic activities on Earth may come about.

“We can test the feeling world of Humankind, and judge exactly the

level of its development. At the present time the percentage of your people who have more fear than we would want to cause, is about six percent. Now the question is, how low must that percent register before we could take a chance on landing in large numbers? We feel that if it goes down below three percent, we can land in quite large numbers. We would experiment with it, if the number got down to that point. However, the percentage has not been lowering very much, so we hope there will be an improvement.

“There are more people in certain areas who would allow fear, and in this regard, your United States is a little bit lower than some of the other places because of experience and more publicity about UFOs, but you are still not down to three percent.

“We have been preventing your Earth from going into a flip on its axis, which would change the positions of your polar regions by displacing your equator. Such a displacement cataclysm would practically wipe out most of the life on Planet Earth; and if we needed to do this, *we would just withdraw the help which we have been giving, to hold your World in its orbit.* Should it become necessary to withdraw our help, your planet would go into the flip on its axis, which in turn would soon end wars of any kind, and wash and cleanse the whole of Earth and begin its final purification.

“If that happened, it would only be a matter of minutes - an hour at the most -during which *we can pick up the persons to be saved.* There are almost 13,000,000 Space Ships close to your Earth now. Most are still in the finer dimension, so you do not see them. However, we can shift into another dimension which would be closer to your Third Dimension - close enough so we could pick up all of you beloved, precious ones in your physical bodies, and save those of you who would be proper to populate the Earth in the New Age, when you will have 'Heaven on Earth.'

“Work on your feeling world so that you are always at peace. Do not become disturbed. A disturbed climate would be dangerous if suddenly this activity of Earth's flip on the axis took place. Do not let anything *in* to disturb you. If someone started an atomic war, or earthquakes, hurricanes or any violence of that nature appeared, your inner disturbance and fear would endanger you. Without fear, you are protected by the Light which you have drawn about you, and the greater Light which you continue to draw.

“Sad to relate, as the energies are stepped up and frequencies increased, the evil forces are more active. They are in their last throes, as it were, and some of them are getting desperate. They feel that they may not be able to accomplish their mission in

NESARA stands for: National Economic Security and Reformation Act

Most of us can probably remember Willie Nelson doing the “Farm Aid” concerts in order to help farmers save their farms. Willie Nelson began doing “Farm Aid” concerts to raise money for the farm families who were losing their farms in the 1970’s and 1980’s.

In the 1990’s some U.S. farmers took actions that had been put into motion years earlier and sued U.S. bankers for having illegally foreclosed on their farm properties. These farmers, having done extensive research, realized that many of the farm foreclosures were due to illegal tricks by the U.S. bankers. The farmers’ lawsuits uncovered collusion by corrupt U.S. government officials with the dishonest bankers. A whole array of farmers’ lawsuits went through the State, Federal, and U.S. Supreme Court processes. The U.S. Supreme Court decisions found that the farmers’ petitions were valid.

The Supreme Court validated the farmers’ petitions for restitution from the U.S. Federal Government by awarding restitution to the farmers. Due to the massive government fraud, there was also a requirement that other Americans be given the opportunity to file for restitution of damages done by the Federal Government. These historic court decisions became the basis for the process by which people in all 50 states of the United States submitted farm claims and bank claims for restitution for damages by the Federal Government. We all owe these brave farmers, attorneys, and U. S. Supreme Court judges in the “Farm Claims” lawsuits a huge debt of gratitude for having taken on the Federal Government and the bankers, thereby exposing their corruption and illegal tricks.

In addition to the awarding of financial damages the U.S. Supreme Court found that the farmers’ claims of Federal Government fraud were also true. The U.S. Supreme Court required that major government reforms be enacted at the same time as the payment of damages to the “Farm Claims” people. The U. S. Supreme Court’s finding on the “Farm Claims” lawsuits of Federal Government fraud are part of the legal foundations of NESARA. It was stipulated that all these landmark court decisions remain secret until the government and banking reforms were ready to be made public and the “Farm Claims” restitution funds were ready to be paid.

In June, 2000, a secret law (NESARA) previously passed in March, 2000, by the U.S. Congress came to the attention of some citizens. This law was passed constitutionally and included a gag order with the penalty of death, if any official involved publicly discussed it prior to its official announcement.

In this same month, (June, 2000) a White Knight (a military intelligence contact), said that this secret law:

- * eliminated the IRS and Federal Income taxes;
- * provided certain major debt forgiveness for people in the U.S.
- * would implement a new U.S. banking and monetary system, using precious-metals backed currency.
- * would absorb the Federal Reserve into the U.S. Treasury Department;
- * would restore our personal liberties, and
- * implement massive improvements in the Federal Government, and much more

In mid-October, 2000, a White Knight high intelligence contact advised that the secret law had been signed by President Bill Clinton on October 10, 2000, and a few days later the acronym assigned to it's name was -- NESARA. This stands for National Economic Security and Reformation Act.

Because of the U. S. Supreme Court's requirement to keep the lawsuits secret, all official word of NESARA was forbidden until the corrections to the Federal Government, banking improvements, and prosperity programs distributions were ready to be implemented. That is why the public has never heard about these landmark decisions. This is why the first official word on NESARA is to be the pending public announcement to all humankind.
